President Report (A. Portmann):

Email sent out regarding team survey

\$1000 grant from Rotary again; Rotary has done that past 3 years; Rotary Scholarship needs to be specific/write up specific; In return, Octoberfest team helps supply volunteers. Teresa – family qualifies for scholarship from PPD, swim team gives same % off as PPD; President and Teresa (treasurer) decide best way for scholarships.

Ben Stepp Scholarship fund – can see about supporting other than travel meets.

Town Hall Meeting – bring up carpooling if needed

Ann will keep her superuser access going until March 31st, and she requested to be the one to delete herself out of there. And let Tom delete himself out. Dustin and Tony are remaining superusers, as well as escrow. Kept superuser at a very limited number.

Head Coach Report (T. Gallagher):

45 kids tried out over the 2 days. Finished 12th at Sr. Champs. 2 Boys qualified for NCSA. Leave for Orlando tomorrow. Finished 16th at JOs. Set state record in 13-14 boys 800 free relay. April 27th 3-5pm at Birchwood (Town Hall Meeting)

Asst. Superintendent of Recreation Report (D. Danz/P. Griffin):

Patrick will take over Donelda's duties directly overseeing pool operations. Donelda still available if he is not.

Pool Time Update – no specifics on 211 update. Augie may be trying to be involved with outside rental process. New person coming in is easy to work with. Keith and Donelda going to meet with him shortly.

One place that looks promising for this fall is Elk Grove Pavillion off of Biesterfield.

Reached out to Y in Lake Zurich; also a facility in Streamwood being looked into.

Treasurer Report (T. Stepp):

February 2014 financials

Moved \$45,000 after early bird to Money Market account. We have about \$130,000 in the Money Market now.

We have about \$600 more in vendor rebates to come in (from Winter Splash).

That was a good budget number for Winter Splash.

We had about \$28,000-\$30,000 in extra income as a cushion last year. We may need to re-evaluate fees and budget in light of this pool time rental situation.

Deposited about \$52,000 after Early Bird. Hoping to get another \$8000 to be on target for budget.

Tom Lucas moved to approve, Graham seconded. All in favor.

Escrow Report (T. Rothmeyer):

Tracy is working on finishing up Early Bird Registration.

Vice-President Report (G. Nelson):

Wanted to publicly thank Ann for all she has done for the swim team...all roles, all the time she's put in over the past years.

Need to set up a committee meeting for Town Hall Meeting. Tony may have some stuff to raffle off. Perhaps have extra voucher for new parents.

Maybe have a Dine and Share at Culvers after the Town Hall. Perhaps Lisa and/or Susan Dunne to coordinate.
